## Categories of Visiting Membership

### Type A

Children of current Members over 21 and below 25 years of age who are full-time students of any recognized educational institution and NOT residing in Singapore.

**Documents required: passport-size photo (1), student pass, passport and social pass**

**Fee: S\$170.67/-\*\* per month or S\$42.67/-\*\* per week or part thereof per person.**

---

### Type B

Visiting relatives (no age restriction) or children of Members over 21 years of age and NOT residing in Singapore.

**Documents required: passport-size photo (1), passport and social pass**

**Fee: S\$243.64/-\*\* per month or S\$60.91/-\*\* per week or part thereof per person.**

---

### Type C

Any person or family\* of good standing, on social visit and temporarily residing in Singapore.

**Documents required: passport-size photo (1), passport and social pass**

**Fee: S\$604.50/-\*\* per month or part thereof.**

\*issuance of card for children must be between 12 and 21 years old.

---

### Type D

Returning Absent Member.

**Documents required: Absent Member card and passport/ identity card**

**Fee: Family Membership: S\$211.86/-\*\* per month or S\$52.97/-\*\* per week or part thereof.**

**Single Membership: S\$170.67/-\*\* per month or S\$42.67/-\*\* per week or part thereof.**

*\*\*The above fees are inclusive of prevailing Goods and Services Tax.*

#### **Note:**

1. Visiting Membership application must be accompanied by the necessary documents.
2. **As per By-Law 8.6 No Guest:**  
**“A Visiting Member is not entitled to introduce guest to The Club except his or her spouse and minor children.” (Except Type “D”)**
3. A Current Member who sponsors a Visiting Member must be at least 21 years old and be responsible for the conduct as well as any financial liabilities incurred by the Visiting Member.
4. Visiting Membership may be extended to the same person not exceeding three (3) times and 90 days in aggregate within a calendar year.
5. A Visiting Member may not reserve class space earlier than 48 hours ahead of the schedule.
6. **A letter of notification within 48 hours of application is required if a Member wishes to cancel his/her Visiting Membership. Otherwise, fees will be charged accordingly.**
